2022 Petaluma AAA Minor Division City Championships

The tournament will be run under <u>Regular Season</u> Little League Minor Division Rules as published in the 2022 Little League Baseball Rule Book. The following changes or additions will also apply:

A. Rule 4.10(e) the 10/15-run mercy rule will be in effect during this tournament. Continuous Batting Order is in effect. Players shall not sit defensively for 2 consecutive innings (free substitution). 5-Run Rule in effect for the first 4 complete innings. 5th inning (and subsequent innings) will be OPEN (no run limit). NO TIME LIMIT. (Managers/Coaches are reminded to keep the games MOVING!)

POOL PLAY GAMES MAY END IN A TIE.

- **B.** A team may start and continue a game with 8 players. If playing with eight, the 9th spot in the batting order will be SKIPPED for purposes of this rule.
- C. Game Balls and Umpires will be provided by the <u>host league</u> for each game. The home team and visiting team have been determined on the schedule. All participants will receive <u>tournament pins</u> at the end of their last pool play game on or before Friday, May 27. There will be 1st and 2nd Place Medals for those finishers. The Champion will also receive a Championship Flag.
- **D.** Refresh yourself on Regulation VI of Little League Rules dealing with pitcher eligibility. Each team will maintain a "Pitching Record" that the opposing manager <u>should</u> sign after each game. This pitching record shall be available for opposing managers to view at any time. Note your pitching eligibility on your lineup card before each game.
- **E.** A plate meeting will be held right before each game to go over the ground rules and to exchange lineup cards.
- **F.** In the absence of an official scorekeeper, the official scorebook for a game will be the home team scorebook. The official pitch count must be agreed to by both teams each half inning and reported to the umpire.
- **G.** There <u>should</u> be a Local League Official at each field for each game. All protests MUST be settled before a game can continue. Please take all appropriate steps to avoid a protest.
- **H.** SAFETY FIRST. All provisions of the District 35 Safety Code will be enforced.
- I. We will maintain "Pool" standings that will show: Wins, Losses, Runs Scored, Runs Allowed, Defensive Innings Played and the "Runs-Allowed Ratio".
- J. TIEBREAKER PROCEDURES (as published by Little League and summarized below)
 - 1. The **first** tiebreaker is "**head-to-head**" record of the teams involved in the tie.
 - 2. The **second** tiebreaker is the "**runs-allowed ratio**" which is the total number of runs given up in all pool play games by that team, divided by the number of defensive innings played in pool play.
 - 3. If more than two teams are involved in a tie, the above tiebreakers will be used, in order, to advance ONE team. (Example: In a 3-team tie, the above tiebreakers are used, in order, to advance one team. Then the tiebreakers are used again, in order, for the other two teams left in the tie.)
